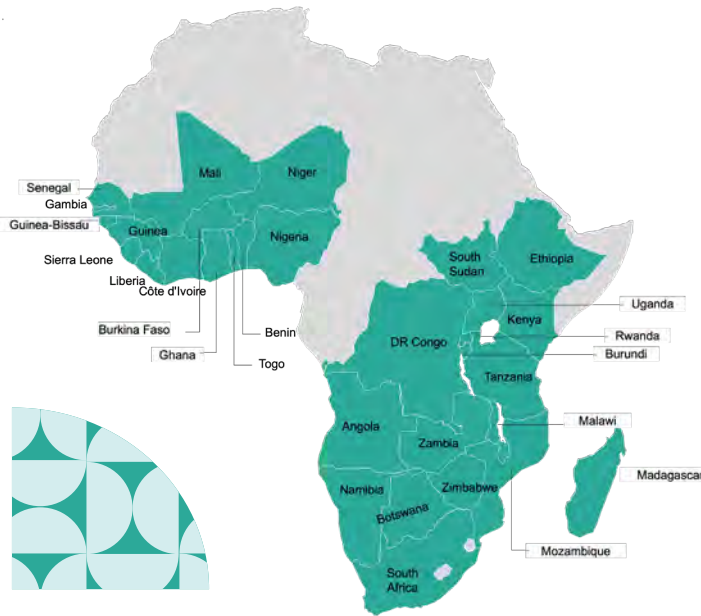

PHARMACOVIGILANCE

Pharmacovigilance is an essential component of our quality management, enabling us to adopt adequate measures to identify and raise awareness about the adverse effects of our products. Through a structured customer complaint redressal system, drug safety complaints are directed to our pharmacovigilance team.

The pharmacovigilance team also undertakes measures to review current literature to understand evolving drug reactions. The redressal mechanism is supported by a dedicated phone line and mailbox, where safety-related complaints are received from patients, and healthcare professionals. We have an established Standard Operating Procedures for diligent follow-up with each reporter. As part of this follow-up, we inquire about the patient's safety and obtain adequate information to assess the drug's safety profile.

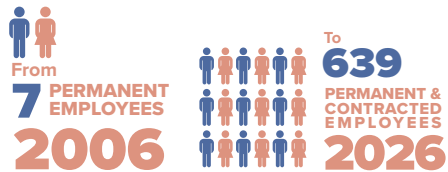

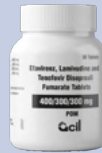

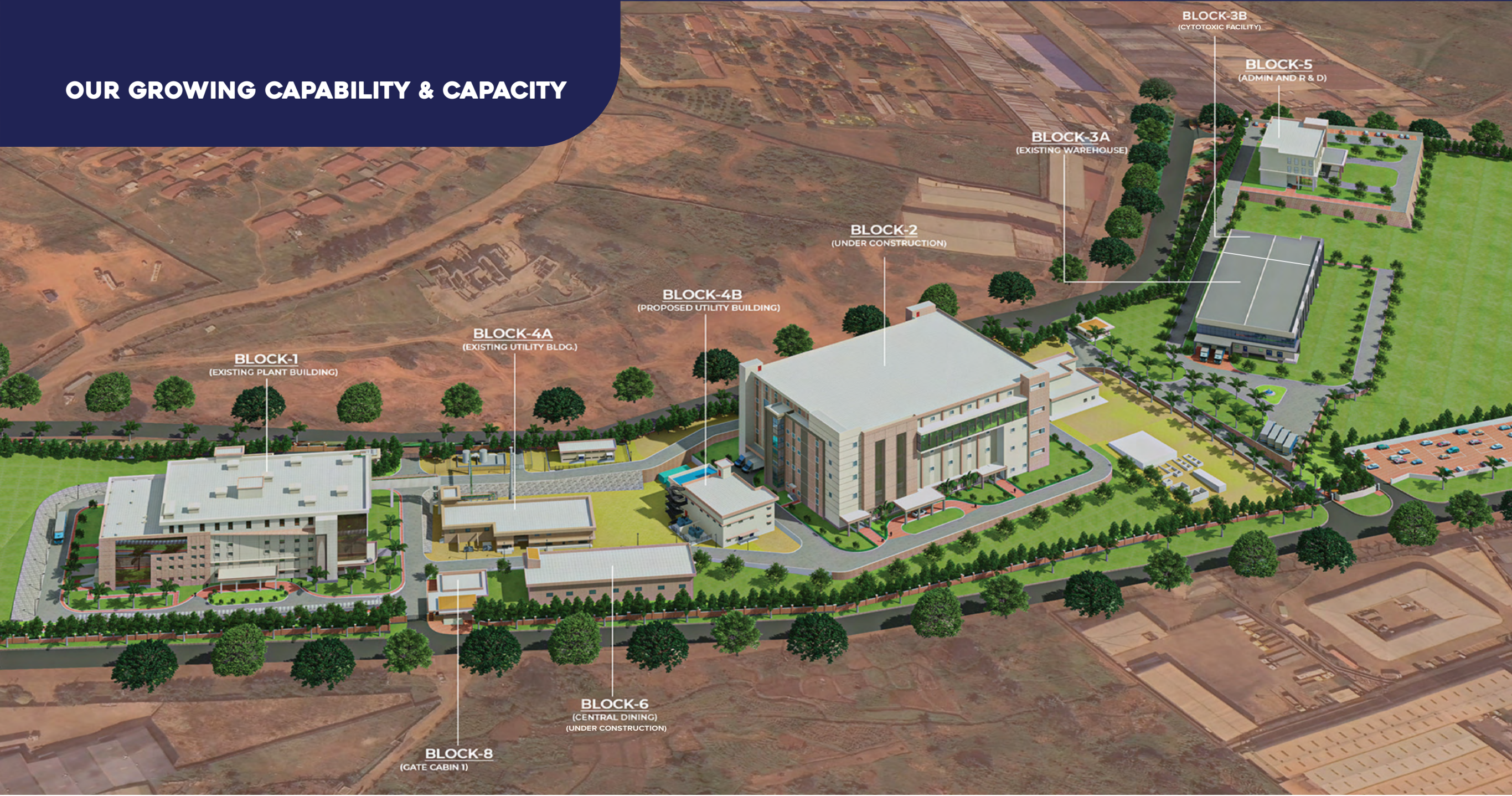
